

ABSTRAK

MUH HIDAYATULLAH, 2021, Pengaruh Kinerja Keuangan Terhadap Harga Saham pada Perusahaan Telekomunikasi yang Terdaftar di Bursa Efek Indonesia. Skripsi, Program Studi Manajemen Fakultas Ekonomi dan Bisnis Universitas Muhammadiyah Makassar. Dibimbing oleh Sitti Aisyah dan Asri Jaya.

Tujuan penelitian ini untuk mengetahui pengaruh kinerja keuangan terhadap harga saham pada perusahaan Telekomunikasi yang terdaftar di Bursa Efek Indonesia tahun 2016-2020. Sampel dalam penelitian ini ialah perusahaan Telekomunikasi yang berjumlah lima perusahaan. Jenis data yang digunakan dalam penelitian ini ialah data sekunder yang diperoleh dari laporan keuangan tahunan perusahaan yang dipublikasikan di Bursa Efek Indonesia tahun 2016-2020.

Hasil penelitian menunjukkan data dengan menggunakan perhitungan statistik melalui aplikasi *Statistical Package for the Social Science (SPSS)* versi 26 menunjukkan bahwa secara parsial *Current Ratio* berpengaruh positif signifikan terhadap harga saham dengan nilai t hitung sebesar $4,437 > \text{nilai } t \text{ tabel } 2,086$, *Return on Equity* berpengaruh negatif signifikan terhadap harga saham dengan nilai t hitung sebesar $3,830 > \text{nilai } t \text{ tabel } 2,086$, *Earning Per Share* berpengaruh positif tidak signifikan terhadap harga saham dengan nilai t hitung sebesar $1,800 < \text{nilai } t \text{ tabel } 2,086$ dan *Debt to Equity Ratio* berpengaruh positif tidak signifikan terhadap harga saham dengan nilai t hitung sebesar $1,557 < \text{nilai } t \text{ tabel } 2,086$.

ABSTRACK

The purpose of this study was to determine the effect of financial performance on stock prices in Telecommunications companies listed on the Indonesia Stock Exchange in 2016-2020. The sample in this study is a Telecommunications company, amounting to five companies. The type of data used in this study is secondary data obtained from the company's annual financial statements published on the Indonesia Stock Exchange in 2016-2020.

The results showed that data using statistical calculations through the Statistical Package for the Social Science (SPSS) version 26 application showed that partially Current Ratio had a significant positive effect on stock prices with a t value of $4.437 > t$ table value of 2.086 , Return on Equity had a negative effect. significant effect on stock prices with a t -count value of $3.830 > t$ -table value of 2.086 , Earning Per Share has an insignificant positive effect on stock prices with a t -count value of $1.800 < t$ -table value of 2.086 and the Debt to Equity Ratio has an insignificant positive effect on stock prices with the calculated t value is $1.557 < t$ table value is 2.086 .
