The problem of poverty and backwardness. 4). Economic and marketing problems, namely the lack of knowing market prices & not knowing how to market electronically

There are various problems that occur that were previously disclosed above, the research team found solutions so that welfare can increase. This research will provide a concept as a principle that can be applied by coastal communities in living a prosperous life in the world and happiness in the hereafter. One of the principles of "Islamic Spiritual Entrepreneurship" instilled in coastal communities is the belief that Allah is almighty and will provide broad sustenance and be blessed by Allah SWT.

On the Principle of "Islamic Spiritual Entrepreneurship", fishing communities in fishing in the sea really need to pay attention to what is recommended and what is prohibited by the government, because regulations on fishing procedures have been considered which are profitable and detrimental (Sutomo et al., 2022). 


Figure 1. Islamic Spiritual Enterpreneurship Design
