

## ABSTRAK

**KHUSNUL KHAIRIAH, 2023 , Tingkat Partisipasi Masyarakat Dalam Pembayaran Pajak Bumi dan Bangunan di Desa Tibona Kecamatan Bulukumpa Kabupaten Bulukumba. Skripsi. Penelitian ini dilakukan untuk mengetahui seberapa besar tingkat partisipasi masyarakat dalam membayar pajak bumi dan bangunan di Desa Tibona Kecamatan Bulukumpa Kabupaten Bulukumba dan faktor-faktor yang mempengaruhinya. Menggunakan metode pendekatan kuantitatif deskriptif populasi dan sampel dalam penelitian ini seluruh wajib pajak bumi dan bangunan di Desa Tibona, Kecamatan Bulukumpa, Kabupaten Bulukumba, jumlah wajib pajak bumi dan bangunan berjumlah 3.310 jiwa. Teknik analisis data menggunakan observasi dan kuesioner . teknik analisis data menggunakan rumus uji t-test, hipotesis awal ( $H_1$ ) penelitian minimal 65 persen. Perhitungan t-test satu sampel dengan menguji t-hitung lebih besar dari t-tabel yaitu 76,17 % . artinya bahwa  $H_1$ diterima dan  $H_2$  ditolak karena mencapai 76,17 % dari angka paling rendah 65%. Dengan demikian, tingkat partisipasi masyarakat sudah cukup baik.

## ABSTRACT

This study was conducted to determine how much the level of community participation in paying land and building tax in Tibona Village, Bulukumpa District, Bulukumba Regency and the factors that affect it. Uses a descriptive quantitative approach method .population and sample in this study all land and building taxpayers in Tibona Village, Bulukumba District, Bulukumba Regency, the number of land and building taxpayers amounted to 3,310 people. data analysis techniques using the t-test formula, the initial hypothesis ( $H_1$ ) of the study is at least 65 percent. The calculation of the t-test of one sample by testing of t-count is greater than the t-table which is 76.17%. meaning that  $H_1$  is accepted and  $H_2$  is rejected because it reaches 76.17% of the lowest figure of 65%. Thus, the level of community participation is quite good.
