

ABSTRAK

Penelitian ini bertujuan untuk mengetahui mekanisme pendistribusian bantuan sosial pemerintah terhadap masyarakat di Desa Toddotoa, untuk mengetahui mekanisme pendistribusian bantuan sosial pemerintah dapat memenuhi prinsip keadilan sosial masyarakat di Desa Toddotoa, dan untuk mengetahui respon dan tingkat kepuasan masyarakat terhadap penyaluran bantuan sosial program keluarga harapan (PKH). Jenis penelitian yang digunakan dalam penelitian ini adalah penelitian kualitatif dengan pendekatan studi kasus. Adapun teknik penelitian yang digunakan yaitu, observasi, wawancara dan dokumen.

Hasil penelitian menunjukkan bahwa dalam pendistribusian bantuan sosial program keluarga harapan (PKH) memiliki mekanisme yaitu dimulai dari pendataan, sosialisasi sampai penyaluran bantuan, serta penarikan bantuan bisa dilakukan di POS dan Bank BNI, namun dalam penyaluran bantuan terdapat kendala yaitu terkendala jarak karena tidak adanya ATM BNI di Desa Toddotoa. Dan pendistribusian bantuan sosial di Desa Toddotoa sudah memenuhi prinsip keadilan sosial, dan program keluarga harapan ini memberikan dampak yang baik karena dapat meningkatkan perekonomian masyarakat namun disamping itu juga memiliki dampak negatif karena membuat masyarakat ketergantungan dengan bantuan yang diberikan sehingga masyarakat belum bisa mandiri sepenuhnya. Dan jumlah bantuan yang diterima berbeda-beda atau sesuai dengan kategori penerima, serta penyaluran bantuan di Desa Toddotoa sudah tepat waktu dan kinerja pendamping PKH sudah bagus dan amanah dalam menjalankan tugasnya.

ABSTRACT

This study aims to determine the mechanism for distributing government social assistance to the community in Toddotoa Village, to determine the mechanism for distributing government social assistance to fulfill the principles of social justice for the community in Toddotoa Village, and to determine the response and level of community satisfaction with the distribution of social assistance for the Family Hope Program (PKH). The type of research used in this research is qualitative research with a case study approach. The research techniques used are observation, interviews and documents.

The results showed that in the distribution of social assistance the Family Hope Program (PKH) had a mechanism that started from data collection, socialization to distribution of aid, and withdrawal of assistance could be done at POS and Bank BNI, but in the distribution of assistance there were constraints, namely distance constraints due to the absence of ATMs BNI in Toddotoa Village. And the distribution of social assistance in Toddotoa Village has met the principles of social justice, and this family of hope program has a good impact because it can improve the community's economy but besides that it also has a negative impact because it makes the community dependent on the assistance provided so that the community cannot be fully independent. And the amount of assistance received varied or according to the category of recipients, and the distribution of assistance in Toddotoa Village was timely and the performance of PKH assistants was good and trustworthy in carrying out their duties.
