SCENARIO FERDY SAMBO ORDERS TO KILL BRIGADIR JOSHUA MAINTAINING FAMILY DIGNITY, EXECUTIONS, OR MOTIVES

ABSTRACT

The president also reminded the National Police to reveal the case of Brigadier J as it is. This, said Jokowi, is to maintain the image of Polri in the eyes of the public. National Police Chief Gen. Pol. Listyo Sigit Prabowo confirmed that there was no shooting incident in the case of Brigadier J's death. Based on the results of the work of the special team, it is known that Bharata E allegedly shot Brigadier J on orders from Inspector General Ferdi Sambo alias FS. Then it was engineered that a shootout occurred; this was to make it appear as if a shootout had occurred. Brother FS shot J's weapon into the wall many times to make it appear as if a shootout had taken place; Ferdy Sambo became the director behind this murder, including those who designed a fictitious story to cover up the real incident. Then Bharada Eliezer was allegedly the executor who shot Brigadier J, which was carried out on orders from Ferdy Sambo. There were at least three roles played by Ferdy Sambo in this case, including 1). The first role played by Ferdy Sambo was to order the murder of Brigadier J. He ordered the suspect, Bharada E, to shoot Bharata J at his official residence at the Police Complex, Duren Tiga, South of Jakarta 2). The second role is to kill Brigadier J; 3). The third role is to design scenarios as if there was shooting action. Based on the results of the investigation, the four suspects were suspected of committing criminal acts following Article 340 of the Criminal Code on premeditated murder, a subsidiary of Article 338 of the Criminal Code on murder, and Junction Articles 55 and 56 of the Criminal Code on conspiracy. The threat of the death penalty, life imprisonment, or a maximum of 20 years in prison. In addition to criminal matters, Ferdy Sambo's actions are suspected of violating the Police's professional code of ethics. He is suspected of having behaved unprofessionally in handling the scene of the death of Brigadier J. along with 31 other police personnel who are currently being investigated for: 1). Violating Polri's professional ethics, 2). Obstructing the investigation process by eliminating evidence such as CCTV footage and autopsy process; 3). Committing unprofessional actions when handing over Brigadier j's body to the family in Jambi. As a result of this action, the Police locked up 11 officers in a special place related to the death of Brigadier J. So far, 11 officers have been locked up in special placements to undergo the provost's examination process.

INTRODUCTION

President Joko Widodo or Jokowi responded that the National Police would announce a new suspect in the case of the death of Brigadier J or Yosua. Jokowi asked the National Police not to hesitate in announcing new suspects or uncovering this case. "From the beginning, I have said, from the beginning, I have told you to

investigate thoroughly. Do not hesitate. Do not cover up anything" (Jokowi in Pontianak, Kalimantan West, Tuesday:9/8/2022).

The president also reminded the National Police to reveal the case of Brigadier J as it is. This, said Jokowi, is to maintain the image of the Police in the eyes of the public. "Reveal the truth for what it is, reveal the truth for what it is, so that it does not lower the public's trust in the Police. That is the most important thing. We must maintain any image of the Police," he explained. Jokowi.

National Police Chief Gen. Pol. Then Bharata Eliezer was allegedly the executor who shot Brigadier Yoshua. According to the National Police Chief, this action was allegedly carried out on orders from Ferdy Sambo. Shootout Role

Former Kadiv Propam Polri Inspector General Ferdy Sambo has named a suspect in the murder case of Brigadier J. Ferdy Sambo played at least three roles in the case, including ¹⁾. The first role that Ferdy Sambo played was to order the murder of Brigadier J. He ordered the suspect Bharada E to shoot Bharata J at his official residence at the Police Complex, Duren Tiga, South Jakarta; ²⁾. The second role is to kill Brigadier J; ³⁾. The third role is to design a scenario as if there was a shooting action by the Inspector General of Police; FS ordered and scenarios the event as if there was a shooting incident at the official residence of Inspector General of Police Ferdy Sambo at the Duren Tiga Police Complex,".

Ferdy Sambo is also suspected of engineering the shooting action of Brigadier J and Bharada E, while Brigadier Ricky and Kuwait are suspected of helping and witnessing the shooting incident. Based on the investigation results, the four suspects were suspected of committing criminal acts following Article 340 of the Criminal Code on premeditated murder, a subsidiary of Article 338 of the Criminal Code on murder, and Junction Articles 55 and 56 of the Criminal Code on conspiracy. "The threat is the death penalty, life imprisonment, or a maximum of 20 years.

In addition to criminal matters, Ferdy Sambo's actions are suspected of violating the Police's professional code of ethics. He allegedly behaved unprofessionally in handling the scene of the death of Brigadier Yoshua at his official residence. Together with Ferdy, there is 31 other police personnel who are currently being investigated for:

- 1. Violating the professional ethics of the Police;
- 2. Obstructing the investigation process by eliminating evidence such as CCTV footage and autopsy process;

3. Taking unprofessional actions when handing over the body of Brigadier Yoshua to his family in Jambi. "The element of suspicion is that things are closed and engineered," explained the National Police Chief. As a result of the alleged unprofessional behaviour of the 31 personnel, the process for handling the death of Brigadier Yoshua became awkward and not transparent.

As a result of this action, the Police locked up 11 officers in a particular place related to the death of Brigadier J. So far, 11 officers have been locked up in special placements to undergo the provost's examination process. Apart from Ferdy Sambo, the other officers consist of two one-star generals, two Chief Commissars, three Adjutant Police Commissars, two Police Commissars, and one Adjunct Police Commissioner.

Formulation of the problem

Based on the background above, the problem formulation in this paper is: Scenario Ferdy Sambo Orders to Kill Brigadier J, Protects Family Dignity, Pretext or Motive?

Research purposes

Departing from the formulation of the problem above, the purpose of this study is expected to be able to examine and analyze the Scenario Ferdy Sambo Orders to Kill Brigadier J, Maintaining Family Dignity, Pretext or Motive.

DISCUSSION

KOMPAS.com² - The case of the death of Brigadier Novriansyah Yosua Hutabarat or Brigadier J involving high-ranking officials from the Indonesian National Police (Polri), Inspector General Ferdy Sambo, has not only become a national public concern but also international. This can be seen from a number of major foreign media which also reported on the case, which has been declared a premeditated murder. Here are five international media that discussed the Brigadier J case, along with the points of view they raised:

- 1. The Straits Times First is The Straits Times media. This media has been reporting on the case of Brigadier Yosua or Brigadier J and Inspector General Sambo since mid-July 2022. On 18 July 2022, the Straits Times wrote an article entitled "Death of Bodyguard: Indonesian Police General Suspended." Also read: 3 Police Generals Removed from Position Due to the Death of Brigadier J, Including Inspector General Ferdy Sambo. It is reported that the family of Brigadier J said the death of their members was premeditated murder. This was because injuries were found on Brigadier J's body, and the injuries did not match the incident stated by the police. Previously, the police stated that Brigadier J was involved in an exchange of fire with other members because there was an alleged affair between Brigadier J and the wife of Ferdy Sambo. Also read: Track Record of Inspector General Ferdy Sambo, Former Head of the Propane Police Division Suspect in the Murder of Brigadier J
- 2. Channel News Asia Next is Channel News Asia (CNA), which on Wednesday (9/8/2022) wrote an article entitled: "General Indonesian Police Charged with Premeditated Murder of His Bodyguard." This indictment was leveled against the 2-star Police General following the unusual death of his aide. For what he did, Sambo was threatened with the death penalty. Also read: List of Police Dismissed As a result of the Brigadier J Case;
- 3. The Sydney Morning Herald Jakarta, Thursday (4/8/2022). Inspector General of Police Ferdy Sambo has been questioned as a witness more or less seven times by Bareskrim Polri about the alleged crime by police shooting police at his official residence, which killed Brigadier J. The third international media that covered the news about Ferdy Sambo was The Sydney Morning Herald. This Australian media wrote an article entitled "General Charged with Murder in New Story for His Bodyguard Case" on Wednesday (10/8/2022). This article states that the news of the murder of a young officer at the Sambo official residence has dramatically developed in Indonesia. It's not just crime cases that are of public concern but also the good name of the National Police, which is threatened if the institution fails to reveal what happened;
- 4. South China Morning Post Next is the media from China, South China Morning Post. In contrast to other media, which highlighted the charges against Sambo, this media raised the involvement of President Joko Widodo (Jokowi), who asked that everything be resolved transparently. "Indonesian President Widodo Urges Transparent Investigations to Be Conducted, Because the Murder Case of a Police Adjutant Shakes Trust," SCMP wrote, Wednesday (10/8/2022).

However, SCMP did not fail to mention that Sambo has now been named a suspect, having previously made up a story to cover up what happened;

5. The Star

The latest media to raise the issue of the premeditated murder of Brigadier J is the media from Malaysia, The Star. On Wednesday (10/8/2022), they published a story entitled "Former Police Officer Ferdy Ordered and Covered Up the Murder of Joshua." The Star narrates how this case has spawned a lot of speculation and mixed information among the Indonesian people in the last few weeks. Until it was finally discovered, Ferdy Sambo had made up a story to cover the real murder incident, and he was made a suspect. Even the determination of the suspect was surprisingly conveyed directly by the Chief of Police.

The cases of Brigadier J and Ferdy Sambo are at stake for the Marwah of the Police.

Merdeka.com³ - Commission III of the Republic of Indonesia DPR held a Hearing Meeting (RDP) with the National Police Chief, General Listyo Sigit, to ask for an explanation regarding the case of the death of Brigadier J who dragged Inspector General Ferdy Sambo's name. Listyo and the extraordinary team arrived at the Senayan Parliament Complex on Wednesday, 24 August 2022, at around 09.45 WIB.

The Chairman of Commission III, Bambang Wuryanto alias Bambang Pacul opened the meeting. "The meeting is open, but if you have something to say in writing.

In his initial presentation, Listyo stated that his party was solid in handling the case. "We are here with a team of 18 people. We are handling this case solidly, so that is one thing we need to convey. Listyo emphasized that handling the case was a bet on the dignity of the National Police. "So, of course, this is our guideline because this is the stake for the National Police's dignity in uncovering this case,"

Previously, the Head of the Public Relations Division of the National Police, Inspector General Dedi Prasetyo, stated that Listyo, accompanied by the special team, would convey the progress that had been carried out by the special team, both from the investigation and also from the inspectorate.

"The entire Timsus are present to accompany the chief of police," said Dedi at the Senayan Parliament Complex Wednesday (24/8/2022).

Meanwhile, Deputy Chair of Commission III of the DPR, Desmond Mahesa, stated that tomorrow's meeting would likely have two open and closed sessions. Because this case is not yet P21, if it is not P21, some things cannot be disclosed to the public because the possibility is closed in the investigation process."

Shootout Scenario

It has been almost a month, and the case of Brigadier J's death has not yet found a light. The Police said Brigadier J was involved in a shootout with Bharada E at the official residence of the non-active Police Head of Propam Division Inspector

General Ferdy Sambo in the Duren Tiga area, South Jakarta, last Friday, July 8, 2022.

However, the family found several irregularities. One is the matter of several cuts found on Brigadier J's body.

A special team (Timsus) for the Police carried out a forensic laboratory ballistic test which was carried out at the official residence of the non-active Head of Propam Polri division, Inspector General Ferdy Sambo, in the Duren Tiga area, South Jakarta, Monday (1/8/2022). The unique team formed by the Indonesian National Police Chief, General Listyo Sigit, conducted an in-depth laboratory ballistic test to investigate the shooting of Brigadier Joshua or Brigadier Nopriansyah Yoshua Hutabarat, especially regarding firearms or ballistics. The National Human Rights Commission (Komnas HAM) has presented new witnesses in the case of a shootout at the residence of the inactive former Head of the Propam Polri Division, Inspector General Ferdy Sambo, which killed Brigadier J. The head of Komnas HAM, Ahmad Taufan Damanik, said that even though the condition of the CCTV at the scene was damaged, his party was able to receive information from witness statements from Bharada E and Bripka Ricky, regarding "Allegations of abuse, for example. That is Bripka Ricki, and Bharada E did not witness. He only heard screams from the mother," said Komnas HAM Chairman, Ahmad Taufan Damanik, Tuesday (2/8/2022).

After asking for information from Brigadi J's family, Damanik said there was so much information obtained when Komnas HAM asked for information from the people closest to the late Yosua, one of which was from his lover, namely Fera. "From the family, especially including Fera, now there is much information from him that is viral," Fera, who at that time still managed to communicate with J, provided evidence of her conversation with Komnas HAM. "He sent a screenshot at 16.31, still communicating like that, and "dare to say that in our data, on July 8, it was exactly 16.31, then we checked again with Fera,".

Shootout Role

Suara.com⁴ - Former Kadiv Propam Polri Inspector General Ferdy Sambo has been named a suspect in the murder case of Brigadier J. Ferdy Sambo played at least three roles in this case, including⁵:

- 1. Ferdy Sambo's first role was to order the murder of Brigadier J. He ordered the suspect, Bharada E, to shoot Bharada J at his official residence at the National Police Complex, Duren Tiga, South Jakarta.
- 2. The second role is to kill Brigadier J.
- 3. The third role is to design a scenario as if there was a shooting action.

"Inspector General of Police FS ordered the execution and scenario of the incident as if there had been a shooting incident at the official residence of Inspector General of Police Ferdy Sambo at the Duren Tiga Police Complex,"

Create Crossfire Engineering

Suara Bekasi. Id⁶ - National Police Chief General Pol. Listyo Sigit Prabowo confirmed that there was no shooting incident in the case of the death of Brigadier J or Brigadier Nopryansah Yosua Hutabarat alias Josua. Sigit emphasized this in a press conference on Tuesday (9/8/2022) evening.

The National Police Chief said, based on the results of the work of the special team, it was known that Bharada E allegedly shot Brigadier J on orders from Inspector General Ferdi Sambo alias FS. Then, it was engineered that a shootout occurred.

As previously reported, National Police Chief Gen. Pol. Listyo Sigit Prabowo gave a press statement regarding the development of the legal process in the murder case of Brigadier J or Brigadier Nopryansah Yosua Hutabarat alias Josua. "Thank God the Timsus has now found a bright spot" (Kapolri, Tuesday: 9/8/2022).

The National Police Chief said, based on the results of the work of the Special Team, his party had now named Inspector General Ferdy Sambo, or FS as a suspect in the death case of Brigadier J.

He explained that the suspect RE shot the victim Brigadier J on orders from FS or Ferdy Sambo. "There were no facts of the shooting incident as reported. The incident that occurred was a shooting incident,".

Bharada E, Promise SP3

Jakarta (Riaupos. Co)⁷ - National Police Chief General Listyo Sigit Prabowo has revealed the chronology of the shooting of Brigadier Joshua Hutabarat at the official residence of the Head of the Propam Division, Duren Tiga, Jakarta. The first person who shot Brigadier Joshua was not Bharada Richard Eliezer Pudhihang Lumiu alias Bharada E, but Inspector General Ferdy Sambo. Listyo Sigit recounted how Bharada Richard started changing his confession.

Initially, on August 3, Bharada Richard was named a suspect under Article 338 in conjunction with Articles 55 and 56. Then, investigators applied Article 340, a subsidiary of Article 338, in conjunction with Articles 55 and 56. The application of this article made Bharada Richard face the death penalty. Listyo Sigit said that on August 4, Irsus reported the results of an internal examination of the findings of the National Police Team regarding the discovery of personnel actions that hindered the investigation process.

Based on the report, the National Police immediately took action against 35 members. They are considered unprofessional in handling TKP investigations, both during initial handling and during the investigation process. They also make efforts to eliminate evidence, fabricate cases and obstruct the process of law enforcement or obstruction of justice. "Irsus recommends carrying out an examination of the code of ethics and position transfers for violators,"

The National Police Chief said that on August 4, 10 people were immediately transferred, including Head of the Propam Division Inspector General Ferdy

Sambo, Karo Paminal, and Karo Provos. "Alhamdulillah, after the replacement, the mutation was filled with new officials, and the obstacles experienced by investigators have begun to decrease," After that, the investigation ran smoothly and produced results and found a bright spot.

"On August 5, Richard was named a suspect based on a report from Joshua's attorney. At that time, the person concerned conveyed changes related to the previous confession.

Basic Bharda E Follow Command Orders

"Why did the person concern change his confession,

- Bharada Richard does not accept being named a suspect. Bharada Richard admitted that he was not the first person to shoot Brigadier Joshua. He also stated that he shot Brigadier Joshua on orders. "At that time, brother Richard said that he saw the late Joshua lying in a pool of blood. Brother FS stood in front and held a gun, then it was handed over to brother Richard,".
- 2. Bharada Richard has been promised by Ferdy Sambo that he will get SP3 and will not become a suspect. However, the fact turned out that Richard was still a suspect. "So then on that basis, Richard said he would say or provide information honestly and openly," Bharada Richard's confession finally changed all the initial information provided by the Sambo group at that time.
 - Bharada E was finally honest and open in changing his initial statement because he knew that Inspector General Ferdy Sambo had failed to keep his promise. He said this made the investigation into the Brigadier's murder smoother and brighter.
 - "On that basis, Richard stated that he would provide information honestly and openly. This is what made all the initial statements change,"
- 3. Bharada Richard received a promise from Inspector General Ferdy Sambo to stop the murder case of Brigadier J. The promise was made so that Bharada E was willing to shoot Brigadier J.

Ferdy Sambo's motive allegedly ordered Bharada E to shoot Brigadier J.

Reported by Kompas.com, Tuesday (9/8/2022), Sigit revealed that Ferdy Sambo ordered Bharada Richard Eliezer or Bharada E to shoot Brigadier J. He stated this at a press conference at the National Police Headquarters, Jakarta. Tuesday night. "The Timsus found that the incident that occurred was the shooting incident of Brother J which caused J to die, which was carried out by RE (Brigadier E), on orders from brother FS (Ferdy Sambo)."

So, what was Ferdy Sambo's motive for ordering Bharada E to shoot Brigadier J? The motive is still being investigated; his party is still exploring the statements of the witnesses regarding Ferdy Sambo's motive for giving the order. "Regarding the motive, currently, an investigation is being carried out on the witnesses and also on Mrs. Daughter,"

In the Riddle of the Alleged Police Shooting Case, the Police still cannot conclude what Inspector General Sambo's motives were for ordering the killing. However, he confirmed that this motive was the main trigger for the murder. "So, at this time, we cannot conclude, but what is certain is that this was the main trigger for the murder incident. What is the conclusion for this? The team continues to work, several witnesses are being examined, and of course, we will inform you later."

In order to carry out the president's order to uncover the riddle and the main motive of the Police Shooting Case and this motive in a fast, transparent and accountable manner in the case of Brigadier J, the National Police Chief formed a Special Team consisting of Komjen Gatot who will be assisted by Irwasum Komjen Agung Budi Maryoto, Kabareskrim Komjen Agus Andrianto, Kabaintelkam Komjen Ahmad Dofiri, and As HR Inspector General Wahyu Widada is working.

The unique team is tasked with investigating the crime scene (TKP), autopsy results, and the statements of several witnesses guided by scientific crime investigation so that the results are objective and open to the public.

"It is hoped that this step will be able to ensure that the investigation process is carried out following objective rules and that all analysis of conclusions is based on proven field facts. Both through a scientific approach and related experts. Apart from that, cross-checking testimony is also important,".

Police Suspect Shoots Police

The Head of the Criminal Investigation Agency (Kabareskrim) of the National Police, Komjen Agus Andrianto, explained the role of the four suspects, including Ferdy Sambo, in the alleged murder case of Brigadier J. Apart from Ferdy Sambo, three other names, namely Bharada E, Ricky Rizal or Brigadier RR, and KM. "The incident, which was hidden during the investigation process carried out by Bareskrim, has named four suspects. Bharada E, Brigadier RR, KM, and Inspector General FS".

Agus also explained the role of each suspect. Following are the roles of Ferdy Sambo to Bharada E:

- 1. Bharada E: shot the victim
- 2. Brigadier RR: helped and witnessed the shooting of the victim
- 3. KM: helped and witnessed the shooting of the victim
- 4. Inspector General Ferdy Sambo: ordered and created a scenario of events as if there was a shootout at Inspector General Ferdy Sambo's official residence in Duren Tiga.

Police Laws Shoot Cops

Ferdy Sambo is the fourth suspect in this case. The other three cases are Bharada E, Bripka RR, and KM. Head of Police Public Relations Division Inspector General Pol. Dedi Prasetyo said Ferdy Sambo had no longer served as Head of the National Police Task Force since being deactivated from the position of Head of the Professional and Security Division. "Automatic (deactivated)," the position of Head of the Task Force is non-structural in the Propam Polri Division. This means that when Ferdy Sambo is deactivated from his structural position as Kadiv Propam Polri, he will automatically no longer serve as Head of the Task Force.

Bharada E was considered to have played a role in shooting the victim; Bripka RR assisted and witnessed the shooting of the victim, and KM did the same thing with Bripka RR.

Based on the examination results, the investigator applied Article 340 subsidiary Article 338 junction Article 55 and Article 56 of the Criminal Code. "With the maximum threat of death penalty, life imprisonment or imprisonment for a maximum of 20 years."

Liputan6.com, Jakarta - Attorney for Brigadier J alias Yoshua Hutabarat, Kamaruddin Simanjuntak, revealed many things after the second autopsy that was carried out on his client, including:

- 1. "The second autopsy, one of which was that the brain was not found in the head. Then there was glue on the back of the head; then the hair was bald, and all traces of glue were f after being bound. The glue was removed and stabbed in the eye; stuck, it did not penetrate.
- 2. The second autopsy found that four bullets exploded in Brigadier J's body and went through.
- First shot from behind through to the top of the nose. At that time, I showed a picture of it being sewn;
 - The second shot, the bullet penetrated from below the neck to the lower lip;
 - The third shot from the chest goes through the back;

- The fourth shot, from the wrist inside, was stabbed through and out; four bullets, or suspected bullets, went through.

Jambipos, Jambi-Photos, and videos of injuries to Brigadier Nofriansyah Yosua Hutabarat's body are circulating on social media and making netizens sad to see them. The photos and videos were posted by one of the lawyers for the Yosua Hutabarat family, namely Lamsiang Sitompul. Since the photo was broadcast 13 hours from Wednesday (20/7/2022) at 07.42, it has been viewed 300 thousand, shared 3 thousand times, and commented on 419.

As previously reported, Brigadier Nofriansyah Yosua Hutabarat died unnaturally at the Office of the Head of Propam Polri Division, Inspector General of Police Ferdy Sambo Inspector General Ferdy Sambo on Friday 8 July 2022, at 17.00 WIB. Brigadier J's body was buried in Suka Makmur Village, Sungai Bahar District, Muarojambi, Jambi Province, Monday (11/7/2022).

The unnatural death of Brigadier Nofriansyah Yosua Hutabarat has attracted public attention since Monday (11/7/2022), both in mass media and social media.



Special Team Findings

National Police Team Searches Inspector General Pol Ferdy Sambo's Private House (Antara / Galih Pradipta / aww.) Brigadier Yoshua's Death Case On Tuesday (9/8/2022), National Police Chief General Police Listyo Sigit Prabowo announced Ferdy Sambo as a suspect in the alleged murder case of Brigadier Nofriansyah Yoshua Hutabarat or Brigadier J. With this development, there are now four suspects in this case, namely Ferdy Sambo, Bhayangkara Dua Richard Eliezer Pudihang Lumiu or Bharada Eliezer, Brigadier Ricky Rizal, and a driver named Kuwat. Brigadier Yoshua died on Friday (8/7) last month, at Ferdy Sambo's official residence, in the Duren Tiga area, South Jakarta. Ferdy Sambo is suspected of being the director behind this murder, including those who designed a fictional story to cover up the real incident. Then Bharada Eliezer was allegedly the executor who shot Brigadier Yoshua. According to the National Police Chief, this action was allegedly carried out on orders from Ferdy Sambo.

Ferdy Sambo Allegedly Engineered Action Shootout between Brigadier J and Bharada E While Brigadier Ricky and Kuwat allegedly helped and witnessed the shooting incident. Based on the investigation results, the four suspects were suspected of committing criminal acts by Article 340 of the Criminal Code on premeditated murder, a subsidiary of Article 338 of the Criminal Code on murder, and Junction Articles 55 and 56 of the Criminal Code on conspiracy. "Threats are the death penalty, life imprisonment, or a maximum of 20 years in prison," explained the Chief of Police. The National Police Chief considers that the number can still increase in the future as the investigation process continues.

List of Names of Police Locked Up for Being Dragged into the Ferdy Sambo Case Jakarta, CNN Indonesia - As many as 16 police officers were secured in a special place (patsus) alias locked up because they were suspected of being unprofessional in handling the death of Brigadier Nofriansyah Yosua Hutabarat alias Brigadier J. One of them was Inspector General Ferdy Sambo.

This number experienced the addition of four personnel. Kadiv Humas Polri Inspector General Dedi Prasetyo said the special placement of four personnel was carried out after the Timsus finished holding cases on Friday (12/8/2022) evening. The four police officers are middle-ranking officers from Polda Metro Jaya. They consist of three people with the rank of AKBP and one with the rank of Kompol.

" As of today, 16 people have been placed in special places (patsus): 6 people in Mako and ten people in Provos" (Head of Public Relations Division of the National Police Inspector General Dedi Prasetyo, Saturday: 13/8/2022).

One of the 16 police personnel is the former Head of the Propam Division, Inspector General Ferdy Sambo. However, in this case, Sambo's status was that of a prisoner after being named a suspect.
