### ABSTRACT

The obstacles faced by the police in uncovering this case are 1). Police officers have cleared the crime scene; 2). Brigadier J's HP Lost; 3). Witness Shut Up; 4). Other Obstacles regarding CCTV at the Office House Damaged; 5). Putri Candrawati is a key witness who is still alive. The bright spots for the cases that led to the death of Brigadier J include 1. The presence of Tita President Joko Widodo; 2. There is suspicion of premeditated murder; 3. It has been obtained and turned on CCTV cameras around the crime scene that are lost or dead; 4. Brigadier J's cellphone and CCTV have been examined in a forensic laboratory based on the Scientific Crime Investigation processed by a forensic laboratory; 5. There is a re-autopsy. To open the veil of Brigadier J's case based on President Joko Widodo's order, the National Police Chief finally named a suspect in the shooting case that killed Brigadier Yoshua Hutabarat, based on 1). Initial evidence is sufficient; 2). Other possible suspects; 3). The threat of punishment (Bharada E; 4). Bharata E was arrested; 5). Not self-defense; 6). Murder suspect; 7). Initial chronology.

## INTRODUCTION

The bright spot in the case of Brigadier J's death is slowly starting to appear. New facts were also revealed about the whereabouts of aides in the Police shooting incident that killed Brigadier J. It is known that the police shooting incident involved two aides of Inspector General Ferdy Sambo, namely Brigadier J and Bharata E. In this case, a new figure emerged: Brigadier Ricky. The figure of Brigadier Ricky was in the spotlight in the case of the death of Brigadier Yosua Hutabarat, or Brigadier J, at the official residence of Inspector General Pol Ferdy Sambo. It is known that Brigadier Ricky is an aide to Inspector General Ferdy Sambo. He could be a key witness in the shooting incident at the official residence of Inspector General Ferdy Sambo on July 8, 2022. The name of Brigadier Ricky is still a stranger in the case of the death of Brigadier J. However, Brigadier Ricky suddenly became important in the investigation of the case. Brick Ricky has appeared in summons at Komnas HAM. So far, Bripka Ricky's name has not been widely highlighted by the public regarding the shooting carried out by Bharata E. The figure of Bripka Ricky is still a stranger in the case of Brigadier J's death. However, Brick Ricky suddenly becomes essential in the investigation of this case.

Even though at the time of the incident, Brigadier Ricky was also at the official residence at the Police Complex, Duren Tiga Utara 1, Number 46, South Jakarta. When they went to the official residence, there was another aide of Ferdy Sambo named Bripka Ricky. At that time, he was in another room on the ground floor of the official residence. According to Bharata E's confession, suddenly, at that time, he heard the screams of Ferdy Sambo's wife from inside his room which is also on the ground floor. "He (Bharada E) went up to the second floor to the adjutant room. He was still cleaning. a scream from Putri's mother (Ferdy Sambo's wife. This is from the Bharada E version,". Because he heard a scream, especially when Ferdy Sambo's wife called his name, Bharata E immediately rushed downstairs. However, Damanik did not reveal the position of the aide named Ricky during the shooting incident between Brigadier J and Bharata E. Even though from the information obtained by Komnas HAM at that time, Brigadier Ricky was also at Ferdy Sambo's official residence. Bharata E comes downstairs to see J's brother. He asks what this is; he sees J aiming a gun at him and shoots. After that, he retreated, took a gun, and cocked and shot a gun".

### *Komnas HAM's Version of the Shooting Chronology*

Even without CCTV footage, Komnas HAM revealed the chronology of the shooting involving Bharata Edan Brigadier J at the official house of the non-active Head of the National Police Propam Division, Inspector General Ferdy Sambo. It is known that the CCTV at Ferdy Sambo's official residence, which is said to be the location of the death of Brigadier J, is in a damaged condition. Komnas HAM chairman Ahmad Taufan Damanik confirmed that the CCTV at Ferdy Sambo's official residence was in a damaged condition based on the statements of aides and investigators. "At the TKP, it was damaged. There are also two statements. In the media, it says it was struck by lightning, but the ADC (adjutant) statement is because this official house is rarely used, and this

CCTV has been damaged for a long time. Although there is no CCTV at Ferdy Sambo's official residence, Damanik said that his party received detailed information about the bloody incident involving Brigadier J and Bharata E. Bharada E admitted that he was the one who shot Brigadier J.

#### *Shooting Moments*

Based on the testimony of Ferdy Sambo's aides, including Bharata E, to Komnas HAM, they moved to the general's official residence on Friday (8/7/2022) afternoon at around 16.00 WIB. Previously, they were in the general's private house, about 500 meters from the official residence. The official residence is in the Police Complex, Duren Tiga Utara 1, Number 46, South Jakarta. Meanwhile, Ferdy Sambo's private house is on Jalan Saguling III, Duren Tiga, South Jakarta, or still in the same area. Their goal was to go to Ferdy Sambo's official residence for self-isolation while waiting for the PCR results to come out after carrying out a PCR test at a private home. A few minutes earlier, Putri Candrawati, the wife of Ferdy Sambo, and his aides, including Brigadier J and Bharata E, had just arrived in Jakarta after traveling overland from Magelang, Central Java. Back to Bharata E's confession, said Damanik, when he arrived at the official residence, he immediately went up to the house's second floor to clean up.

Special Team from the National Police and Komnas HAM Looking for Bright Spots on Police Shooting Police Cases. Kompas.TV. National Police Chief General Listyo Sigit Prabowo formed a special team to investigate the case of a shootout between Bharata E and Brigadier Nopryansyah Yosua Hutabarat that killed Brigadier Yoshua at the house of the Head of the Program Division of the National Police Inspector General Ferdy Sambo. Deputy Chief of Police of the Republic of Indonesia, Commissioner General (Komjen) Gatot Eddy Pramono was appointed the head of a unique team. Meanwhile, Human rights commission (Komnas HAM) will conduct its investigation. The National Police stated that the coordination between the two institutions also includes Komnas HAM's access to the investigation data held by the Police. According to the National Police Chief, two criminal allegations are related to attempted murder and threats of violence against women. The house of the Head of the National Police Propam Division, Inspector General Ferdi Sambo, was a silent witness to the shootout.

- a. Academically, this research is helpful regarding the Special Police Team Towards the Bright Point of the Murder Case of Brigadier Joshua.
- b. Theoretically, this research can enrich the literature on the Special Police Team Towards a Bright Spot for the Murder of Brigadier Joshua.

## **METHODOLOGY**

## **RESULTS AND DISCUSSIONS**

Tribunnews.Com, Jakarta - It has been almost a month since the death of Brigadier J has not yet come to light. Although the Special Team formed by the National Police Chief has named Bharata E as a suspect, the public is still waiting for the root cause of this case. However, the determination of the suspect in the case, namely Bharata E, was only carried out yesterday. So what are the real obstacles faced by the Police in investigating this case? Even though a number of people think this is an ordinary criminal case and the perpetrator

of the shooting has been known from the start, namely Bharata E. The following are the obstacles allegedly faced by the Police in uncovering this case, as summarized (Tribunnews.com: 4/8/2022).

**1. The Crime Scene Has Been Cleaned**

The head of the Bhayangkara University Center for National Security Studies, Hermawan Sulisty, said the crime scene had been cleaned by Kombes Pol Budhi Herdi Susanto, who was then the South Jakarta Police Chief, who cleaned the scene. Based on the rules, said Hermawan Sulisty, crime scenes cannot be cleaned. "The physical evidence doesn't exist, it's gone, because the crime scene was cleaned up," said Hermawan Sulisty in Breaking News Kompas.TV, Wednesday (4/8/2022).

**2. Brigadier J's HP Lost**

In addition, Hermawan Sulisty said that Brigadier J's cell phone or cellphone (HP) was not found. "If it's more than that, I think we have to wait for the evidence. There are no cellphones (Brigadier J), confiscated cellphones, all new cellphones," said Hermawan Sulisty. Hermawan Sulisty also understands that the public finally considers the Police to cover up the case of Brigadier J.

"Even though no, it's true that the physical evidence doesn't exist, it can't be found. Well, whether it was removed or damaged or true is still being sought, without any evidence. That the police argument will be very weak, whether it is included in Article 340 or 338, this will be a debate," As is known, repeatedly Kamaruddin Simanjuntak, Brigadier J's lawyer, often asked about the whereabouts of his client's cellphone. However, the Head of the National Police Public Relations Division, Inspector General Pol Dedi Prasetyo, explained that currently, the cellphone is at the Police Forensic Laboratory Center (Puslabfor). Komjen Gatot Eddy Pramono was appointed the head of a unique team. Meanwhile, Komnas HAM will conduct its investigation.

The National Police stated that the coordination between the two institutions also includes Komnas HAM's access to the investigation data held by the Police. According to the National Police Chief, two criminal allegations are related to attempted murder and threats of violence against women. The house of the Head of the National Police Propam Division, Inspector General Ferdi Sambo, was a silent witness to the shootout. *Witness Shut Up*

Hermawan Sulistyono also said that almost all of the witnesses questioned regarding Brigadier J's death made a silent movement. Hermawan calls it GTM or the silent movement. "Then the witnesses don't want to talk all this time, the witnesses are all GTM, the silent movement," "Is it because of pressure, intervention, obstruction of justice or what? We don't know yet because everything hasn't been opened yet,". Other Obstacles About CCTV in the Office House are Damaged the Head of the Public Relations Division of the National Police, Inspector General Dedi Prasetyo, explained the confusing CCTV findings related to the case of Brigadier J's death; there are still many wild narratives and questions about the CCTV. Previously, the police had damaged CCTV at the crime scene (TKP) or the residence of the inactive Police Propam Division Head Inspector General Ferdy Sambo in the Duren Tiga area, South Jakarta.

"There are still many circulating in the media that the CCTV is broken, then why was another CCTV found? I need to straighten this out so that I no longer have perceptions so that speculation arises which makes this problem unclear". Inspector General Dedi emphasized that the damaged CCTV was only at the residence of Inspector General Ferdy Sambo. Meanwhile, the CCTV around the crime scene was not damaged and has been found by investigators. Currently, the CCTV footage found by investigators is still being examined by the Police Forensic Laboratory (Lab). "What was damaged was the CCTV at the crime scene, but the CCTV along this route, around this crime scene, has been found by investigators."

*Princess Candrawati is the Key Witness Who is Still Alive*

Following the results of the Komnas HAM examination, at least four people were at Ferdy Sambo's official residence when the shooting of Brigadier J on Friday (8/7/2022) was observed. They are Brigadier J, Bharada E, and Brigadier Ricky. These three people are an aide to Inspector General Ferdy Sambo. One other person is Putri Candrawati, wife of Inspector General Ferdy Sambo. The head of Komnas HAM, Ahmad Taufan Damanik, said that Putri Candrawati was a key witness still alive in Brigadier J's death. The reason was that Putri's testimony would later be able to explain whether or not there were allegations of sexual harassment by Brigadier J. "This whole incident is a crucial point. in Mrs. Putri (who can) answer whether (there was) a shootout, who did it, whether this sexual harassment really exists or not," said Ahmad Taufan Damanik at the Komnas HAM Office, Jakarta, Tuesday (2/8/2022).

Ahmad Taufan Damanik said that at the time of the incident, two other witnesses were still alive, namely Bripka Ricky and Bharata E. However, these two living witnesses did not witness the whole event. "Ricky himself only witnessed part of it. He did not witness the whole thing," said Ahmad. Typhoon Damanik. Ricky said Taufan only heard Putri's screams but did not know what happened before the shooting, namely the alleged abuse by Brigadier J against Sambo's wife. Putri's statement, said Taufan, was necessary because Komnas HAM could not obtain CCTV evidence inside Inspector General Sambo's house. "It means that the only living witness is Ibu Putri,"

Based on the police's initial explanation, Brigadier J was presumed dead after a shootout with Bharata E at Inspector General Ferdy Sambo's house on July 8, 2022. According to the police, the shootout was triggered by Brigadier J, who abused and threatened by pointing a gun at the head of Inspector General Ferdy Sambo's wife, PC.

*As a Result of the Shootout, Brigadier J Died*

However, Brigadier J's family considered there were irregularities regarding the cause of death because several wounds were found on Brigadier J's body. In addition, CCTV in the house was also reported to be dead. The family also suspected that there was an attempted murder of Brigadier J.

*New Chapter of Police Shooting Police Case*

Kompas.com - 27/07/2022, 11:00 WIB Share: Dismantling Brigadier J's tomb to conduct a re-autopsy so that all irregularities can be transparent. The Police finally granted the request of Brigadier J or Nofriansyah Yosua Hutabarat's family to conduct a re-autopsy. This was done in order to find a bright spot related to Brigadier J's death, whether it was only because of shooting or torture, as alleged by the victim's family lawyer. Today, Wednesday (27/7/2022), the joint forensic team conducted a re-autopsy on the body of Nofriansyah Yosua Hutabarat or often called Brigadier J. The re-autopsy involving forensic experts from the Police, TNI, and representatives of the victim's family is planned to be carried out at the RSUD Bahar River, Jambi. Re-autopsy The re-autopsy, known as exhumation, was carried out to find light on the case of Brigadier J's death. This is because various speculations and suspicions have recently spread regarding the cause of the adjutant's death. Various irregularities were indeed expressed by a number of groups, including the Coordinating Minister for Political, Legal, and Security Affairs (Menko Polhukam) Mahfud MD. The Coordinating Minister for Political, Legal and Security Affairs questioned the delay in the information conveyed by the Police regarding the case of the 'police shooting police at the house of this police officer.

In addition to the issue of the announcement of the case, which was considered slow, the Head of the National Police Commission (Kopolnas) also highlighted the different statements and statements from the Police. The Police's policy of prohibiting the family from seeing Brigadier J's body also raised suspicions. Allegation of torture Public suspicion grew stronger after family lawyers revealed the condition of Brigadier J's body, which was tortured according to their 'alleged' victim. The family and the team of lawyers also suspect Brigadier J is a victim of premeditated murder, not the spontaneous action of his fellow aide. As a result, the public is increasingly suspicious and suspicious. Various speculations and assumptions are scattered everywhere in discussion rooms and on social media timelines. Moreover, this case is peppered with allegations of an 'affair' or love triangle. Police information that Brigadier J became the victim of the Police shooting the Police for trying to harass his superior's wife sexually was considered a figment. Moreover, it was later discovered that Brigadier J already had a partner and would soon get

married. Looking for a bright spot, The Police finally decided to do a re-autopsy. This was done because the family rejected the results of the first autopsy.

The family and the team of lawyers asked for a re-autopsy. They doubt the credibility of the autopsy process that was carried out previously. In addition, the family suspects Brigadier J's death was not the result of a shootout. Police finally granted Brigadier J's family's request for a re-autopsy. In addition to fulfilling the family's request, a re-autopsy was carried out to clear up various speculations and wild issues. The re-autopsy was not only carried out by the forensic team from the Police but also involved the forensic team from the TNI and representatives from the victim's family. This is done to dispel suspicions. Also, this case can be resolved openly and transparently so that it does not leave any questions. It is planned that the re-autopsy of Brigadier J's body will be carried out at Sungai Bahar Hospital, Jambi, not in the cemetery area.

This is done so that the autopsy can be performed optimally. The reason is that if the autopsy is carried out at the burial site, it is feared that it will not run optimally. Besides being in a less spacious location, crowds of people who want to witness can also interfere with the autopsy process. In order to ensure that the autopsy process is as expected, Brigadier J's family will deploy seven family members. Five of them will be in charge of digging graves and opening chests. Meanwhile, two other people who are Brigadier J's uncles will also supervise the entire series of autopsies, from start to finish. Not only that. The police will also install CCTV cameras in the room where the autopsy is carried out. This was done to assure the victim's family and the community that the autopsy was carried out in a professional, independent and transparent manner. We all hope that the re-autopsy process will be able to shed some light on the cause of Brigadier J's death, whether it was due to gunshot wounds or torture, as alleged by the victim's family lawyer.

Various parties are expected to refrain from spreading assumptions and speculations related to this case. And can also receive whatever the results of the re-autopsy performed today. What was the result of the re-autopsy of Brigadier J's body that was carried out today? Is it true that he became a victim of torture, such as a wild issue that developed, or was it purely the result of a shooting.

#### *Important Points for Determining the Suspect Perpetrator of the Shooting*

Tribunnews.Com, Jakarta - The Special Team (Timsus) formed by the National Police Chief General Listyo Sigit Prabowo finally named a suspect in the shooting case that killed Brigadier Yoshua Hutabarat alias Brigadier J at Inspector General Ferdy Sambo's house, Duren Tiga Police Complex, South Jakarta, Friday (8/7 /2022) ago.

#### *Bharata Eliezer alias Bharada E has been Named a Suspect in the Murder of Brigadier J*

The Director of General Crimes (Dirtipidum) of the Criminal Investigation Unit of the National Police, Brigadier General Andi Rian, explained the determination of the suspect Bharada E at a press conference in



Jakarta Wednesday (3/8/2022) night. Tribunnews.com summarizes the following:

1. Proof of starting is sufficient

Brigadier General Andi Rian explained that during the investigation of at least 42 witnesses and several pieces of evidence, investigators found sufficient preliminary evidence to increase Bharada E's status from witness to suspect. "The confiscation of a number of evidence, both in the form of CCTV communication tools, then evidence at the crime scene that has been examined or researched by the forensic laboratory and which is being examined at the forensic laboratory,".

2. Other possible suspects

According to Andi, this case is still being developed, and there may be other suspects in this case. "The examination or investigation does not stop here. So it continues to develop, as well as the records of colleagues, knowing that there are still several other witnesses who will be examined in the next few days," he said.

3. Threat of punishment by Bharata E

The alleged article, Bharata E, faces a maximum sentence of 15 years in prison. Article 338 of the Criminal Code reads, "Anyone who deliberately takes the life of another is threatened with murder with a maximum imprisonment of fifteen years."

4. Bharada E was arrested

Andi explained currently Bharata E is still undergoing examination at the Criminal Investigation Police of the National Police as a suspect. According to Andi, for the sake of investigation, investigators will detain the suspect Bharada E. "We will immediately arrest and detain,"

5. Not self-defense

Brigadier General Andi Rian said the National Police ensured that they did not find any element of self-defense that Bharata E did in the shootout with Brigadier J; it was obtained from the results of the case title witnesses and several pieces of evidence.

6. Murder suspect

"The National Police have named Bharada E as a suspect in connection with the death of Brigadier Nofriasnyah Yoshua Hutabarat or Brigadier J. Bharada E involved in a shootout that caused Brigadier J to die," said Andi Investigators named Bharata E as a suspect and charged him with Article 338 of the Criminal Code on murder, in conjunction with Articles 55 and 56 of the Criminal Code. "Bharada E is suspected of Article 338 of the Criminal Code in conjunction with Article 55 and Article 56 of the Criminal Code. So it's not self-defense," (Andi during a press conference at Police

Headquarters: 3/8/2022). Andi added that currently, investigators are continuing to investigate Bharada E as a suspect.

7. The sound of the alleged article

The articles charged with Bharata E are: Article 338 of the Criminal Code reads, "Anyone who deliberately takes another person's life, is threatened with murder with a maximum imprisonment of fifteen years." Article 55 of the Criminal Code regulates criminal acts of criminal acts. Paragraph (1) point 1 of this article states, "Those who do, those who order to do it, and those who participate in doing the deed." Meanwhile, paragraph (1) point 2 reads, "Those who by giving or promising something by abusing their power or dignity, by violence, threats or misdirection, or by providing opportunities, means or information, intentionally encourage others to do something." Article 56 of the Criminal Code regulates criminal acts as an assistant to crime, which reads, "Those who intentionally provide assistance when a crime is committed; those who deliberately provide opportunities, facilities or information to commit a crime".

8. Initial chronology

Based on the police's initial explanation, Brigadier J was presumed dead after a shootout with Bharata E at the home of Inspector General Ferdy Sambo on July 8, 2022. According to the police, the shootout was triggered by Brigadier J, who abused and threatened the head of Inspector General Ferdy Sambo's wife, PC. Incident.

9. Purbalinggaku: New facts from the police shooting incident that resulted in Brigadier J's death are starting to come to light. Bharata E mentioned his actions on orders from superiors. Through his attorney, Deolipa Yumara, Bharata E admitted that he shot Brigadier J, which was ordered by his superiors, but he could not refuse. "His name is the police, he has to obey orders, as well as our superiors if you become an employee, obey orders from our leaders, it's the same thing," (Deolipa at the National Polic Criminal Investigation Unit, Monday: 8/8/2022). According to him, Bharata E's shooting of Brigadier J on the orders of his superiors was a form of action regulated by law. "There are laws and regulations down there; there are police regulations that work from subordinates to receive orders from superiors. For information, one of Richard Eliezer's attorney's alias Bharada E. He revealed the former Head of the Propane Police Division Inspector General Pol Ferdy Sambo at the location of the death of Brigadier J. His party explained, from Bharata E's confession, that it turned out that Sambo was already at the scene when the incident that killed Brigadier J occurred.

*Police Shoot Police Scenario*

Public news, Jakarta Coordinating Minister for Political, Legal and Security Affairs Mahfud MD- The narrative that the death of Brigadier Nofriansyah Yosua Hutabarat due to a shootout with Bharata E had been

planned at the beginning. Coordinating Minister for Political, Legal, and Security Affairs Mahfud MD said this was refuted following President Joko Widodo's direction to fully disclose the incident at the official house of the Head of the Program Division (at that time) Inspector General Ferdy Sambo. "Well, that's because thanks to all of you, thanks to NGOs, thanks to the seriousness of the Police, thanks to the President's firm direction, previously all the scenarios were reversed. In the past it was said to be shooting, now there is no shooting, now there is murder,". The former chairman of the Constitutional Court (MK) said there were three suspects. According to Mahfud, the case has found a bright spot. "There are already three suspects, three of which can develop, and the articles are 338, 340, the new one is premeditated murder," he said, without mentioning who the three people were. Mahfud explained that the case could be developed to reach a more straightforward case. "(It is known) whether his role is an intellectual actor or an executor," He appreciated the steps taken by the National Police Chief, General Listyo Sigit Prabowo, for handling cases in an environment filled with codes of silence. "Now that the suspect is already there, the high-ranking officials have become stupid, I think what the National Police Chief did was the stages and the speed was quite decent, not too bad,".

Meanwhile, this Monday afternoon, the former Head of the Propane Police Division, Inspector General Ferdy Sambo, underwent an examination by a special team led by the Deputy Chief of the National Police, Komjen Gatot Eddy Pramono. The investigation occurred at the Mobile Brigade Headquarters, Kelapa Dua, Depok. This was conveyed by the Head of the Police Public Relations Division, Inspector General Dedi Prasetyo, at the Brimob Command Headquarters. "All of the Timsus was directly led by the Deputy Chief of Police, Mr. Irwasum, along with all of the Timsus, including those at the Criminal Investigation Unit, all were the same, examining witnesses and also re-analyzing the results of the forensic laboratory,.. Dedi did not explain who was being questioned at the Mobile Brigade Command Headquarters. He ensures that all evidence will be presented directly and explained. Inspector General Ferdy Sambo has been detained in an isolation room at the Mobile Brigade Headquarters for the next 30 days. This is related to the alleged violation of the code of ethics related to the death of Brigadier Joshua. So far, the Criminal Investigation Department has only announced two suspects. They are Bharada Richard Eliezer and Brigadier Ricky Rizal.

#### *Bright Spot of Brigadier J.'s Case*

Intisari - Online.com- A bright spot for the case of the alleged Police shooting the Police causing the death of Brigadier J will soon be found. The Police said that the CCTV camera in the deactivated Police Security (Propam) house, Ferdy Sambo, died, but 12 days after the incident, the Police said that they had obtained CCTV footage that could reveal the death of Brigadier J. Here are some developments in the case of Brigadier J, who died at Ferdy Sambo's house, reported by Kompas.com.

### *Alleged Premeditated Murder*

It is suspected that Brigadier J's cause of death was premeditated murder. The Directorate of General Crimes at the Criminal Investigation Agency of the Indonesian National Police has also raised the case of suspected premeditated murder to the investigation stage. As a result, the Police have found allegations of criminal acts in the case, but no suspect has been identified. The status of this case is still based on the degree of the case that has been done.

### *CCTV Cameras Around the Crime Scene*

A special team will be formed by the National Police Chief General Listyo Sigit, who will open the CCTV and explain the case. The head of the special team will be held by the Police General Supervision Inspectorate (Irwasum) of the National Police, Komjen Agung Budi Maryoto. As stated by the Head of the Public Relations Division of the National Police, Inspector General Dedi Prasetyo, Dedi did not explain in detail the place or location of the CCTV confiscated. Dedi only explained that the confiscated CCTV was near the crime scene (TKP). (Dedi Kompas.com: 21/7/2022).

### *There May be More than One Perpetrator*

Kamaruddin Simanjuntak, attorney for Brigadier J's family, said it was estimated that there was more than one perpetrator. "At least according to our estimation there are several people, not just one person, it could be more than two or three people," (Kamaruddin, Kompas.com: 18/7/2022). This suspicion arose because of the many unnatural wounds on Brigadier J's body. For example, as cuts and bruises on several parts of Brigadier J's body. He suspected that other parties were involved in the torture of Brigadier J before finally being killed by Brigadier J.

### *Jokowi Asks for a Thorough Investigation*

President Joko Widodo (Jokowi) requested that the case that killed Brigadier J be investigated thoroughly. "I have already said that; investigate thoroughly. Open it as it is. Do not cover up anything. Transparent (Jokowi. Kompas.com: 21/7/2022). Jokowi said this was important so there would be no doubt in the community about the Police.

### *The Case of Police Shooting Police Revealed*

Populis, Jakarta - The case of Police shooting Police at Inspector General Ferdy Sambo's house has begun to find a bright spot after the Police secured the cellphone belonging to Brigadier Yosua Hutabarat alias Brigadier J as well as several surveillance cameras (CCTV) around the location of the incident. This case. The Head of the Public Relations Division (Kadiv) of the National Police Inspector General Pol Dedi Prasetyo said Brigadier J's cellphone and CCTV were examined at the forensic laboratory (labfor) by prioritizing the Scientific Crime Investigation approach. Currently, the results of the analysis have not been released. "There are several pieces of evidence currently being examined at the laboratory, including Brigadier J's cellphone, which has been secured and checked by the laboratory. Later, the laboratory will be able to explain it

scientifically, ". "There are several CCTV points that have been secured as well and are currently still in the process of deepening by the laboratory because they must be calibrated later and everything must be recorded very well because there must be an adjustment in time, yes, this is still being studied by the labfor, later the results will be scientifically by the labfor". Dedi explained that the CCTV footage in the forensic laboratory did not only come from the official residence of the former Head of the Propam Division, Inspector General of Police Ferdy Sambo, in South Jakarta.

However, the CCTV footage also came from various regions, which connected with the shooting incident that killed Brigadier J. This includes CCTV recording Ferdy Sambo's journey from Magelang to Jakarta "Yes, everyone, everything related to this incident has been investigated and processed by the forensic laboratory," In order to investigate the case of the shootout of Inspector General Ferdy Sambo's subordinates to a bright spot, the Indonesian National Police formed a special team, which can be seen in the Indonesian language in the image below:

### *National Police Chief Removes Police Personnel Position*

Jakarta (ANTARA) - The National Police Chief General Pol. Listyo Sigit Prabowo took firm action against unprofessional personnel in handling the case of Brigadier J's murder by issuing a transfer telegram and removing 24 personnel. The Head of the National Police Public Relations Division, Inspector General Pol. Dedi Prasetyo, when confirmed through a written message in Jakarta Tuesday, said the 24 personnel were transferred to the Police Headquarters Service (Yanma). "(All transferred) to Yanma Police,"

### *Mutation to Yanma*

The National Police Headquarters (Headquarters) issued a list of the names of 24 police officers who were transferred from their positions to Service Headquarters (Yanma) personnel based on the Chief of Police's Telegram Letter Number; ST/1751/VIII/KEP./2022 dated August 22, 2022. Head of the General Warfare Section (Kabagpenum) of the Public Relations Division of the National Police, Kombes Pol. Nurul Azizah, when confirmed in Jakarta Tuesday, said that the 24 police officers came from a work unit (satker) with ten personnel each from the Propane Division, two Bareskrim personnel, two Korbrimob personnel from the Propane BKO, nine Polda Metro or South Jakarta Police, and one Central Java Police personnel BKO Program.

The mutation consisted of four people with the rank of Police Commissioner (Combes). Five with the rank of Adjunct Senior Commissioner of Police (AKBP), two with the rank of Police Commissioner (Kopol), four with the rank of Adjunct Police Commissioner (AKP), two with the rank of First Police Inspector (Ibu), one with the rank of second Police Inspector (Ipad), one people with the rank of Chief Brigadier (Bripka), two people with the rank of Police Brigadier One (Briptu), and two people with the rank of Bhayangkara Police Two (Bharata). The 24 personnel include a work unit, ten personnel from the Propane Division, two Bareskrim personnel, two from Korbrimob BKO Propane, nine from the Metro Police or South Jakarta Police, and one Central Java Police personnel BKO Program.

The husband and wife pair were supposed to be examined as witnesses in the case of Brigadier J's death. In this case, the National Police have named Bharata E as a suspect in the alleged murder of Brigadier J. "Now that the call has been transferred to the Dirlidum Bareskrim, we have received a call for an examination of Ibu Putri Candrawati, which was supposed to be today," However, in today's examination, only Inspector General Ferdy Sambo fulfilled the examination. Arman also explained why Putri Candrawati could not attend the examination, which has been conveyed to the investigators". Arman explained that the coordination in question was asking investigators to be willing to examine the wife of Inspector General Ferdy Sambo at his residence with clinical psychology assistance. Under such conditions, it is difficult." Ferdy Sambo has been named a suspect in the premeditated murder case of Brigadier J along with four other suspects, namely Bharata Richard Eliezer, Bripka Ricky Rizal, Strong Ma'ruf, and Putri Candrawati. The five suspects were charged with Article 340 of the Criminal Code, subsidiary to Article 338 of the Criminal Code, in conjunction with Articles 55 and 56 of the Criminal Code.

## **CONCLUSIONS AND RECOMMENDATIONS**

Almost one month, the case of Brigadier J's death has not yet come to light. The obstacles faced by the police in uncovering this case are:

1. Police officers have cleaned the crime scene
2. Brigadier J's HP Lost
3. Witness Shut Up
4. Other Obstacles About CCTV in the Office House are Damaged
5. Princess Candrawati is the key witness who is still alive

Putri Candrawathi is a key witness who is still alive in the death of Brigadier J. The reason is that Putri's testimony will later be able to explain whether or not there was alleged sexual harassment by Brigadier J. At the time of the incident, two other witnesses were still alive, namely Bripka Ricky and Bharata E. However, these two living witnesses did not witness the whole event. The bright spot for the case of the alleged police shooting the police causing the death of Brigadier J has pocketed footage from CCTV which can reveal Brigadier J's death; the CCTV footage also comes from various regions, which are indeed related to the shooting incident that killed Brigadier J. Including CCTV which recorded Ferdy Sambo's journey from Magelang to Jakarta, besides that the bright spots included:

1. Carry out Tita Joko Widodo, who asked for a thorough investigation into the death of Brigadier Joshua;
2. Deactivate Fredy Sambo as Head of the National Police Propam Division;
3. Alleged premeditated murder;
4. Find and turn on CCTV cameras around the crime scene that are lost or dead;
5. Brigadier J's cellphone and CCTV were examined at the forensic laboratory (labfor) by prioritizing the Scientific Crime Investigation approach, which related to this incident has been investigated and processed by the forensic laboratory;
6. Demolition of Brigadier J's grave to conduct a re-autopsy so that all irregularities can be revealed transparently.
7. The re-autopsy involving forensic experts from the Police, TNI, and representatives of the victim's family is planned to be carried out at Sungai Bahar Hospital, Jambi; and

To unmask Brigadier J's case based on an order from President Joko Widodo, the National Police Chief, General Listyo Sigit Prabowo, finally named a suspect in the shooting case that killed Brigadier Yoshua Hutabarat; this is based on 1). Sufficient preliminary evidence; 2). Other possible suspects; 3). The threat of punishment (Bharata E; 4). Bharada E arrested; 5). Not self-defense; 6). Murder suspect; 7). and early chronology. There are other steps taken by the National Police Chief Gen. Pol. Listyo Sigit Prabowo, among others:

1. Establishing Ferdy Sambo as a suspect in the premeditated murder case of Brigadier J along with four other suspects, namely Bharada Richard Eliezer, Bripka Ricky Rizal, Strong Ma'ruf, and Putri Candrawathi. The five suspects are charged with Article 340 of the Criminal Code, subsidiary Article 338 of the Criminal Code in conjunction with Article 55 and Article 56 of the Criminal Code.
2. Taking firm action against unprofessional personnel in handling the case of Brigadier J's murder by mutating and removing the positions of 24 Polri personnel as stated in the Telegram Letter of the Chief of Police ST/1751/VIII/KEP./2022. They consist of four people with the rank of Police Commissioner (Combes). Five with the rank of Adjunct Senior Commissioner of Police (AKBP), two with the rank of Police Commissioner

(Kompol), four with the rank of Adjunct Police Commissioner (AKP), two with the rank of First Police Inspector (Ibu), one with the rank of second Police Inspector (Ipad), one people with the rank of Chief Brigadier (Bripka), two people with the rank of Police Brigadier One (Briptu), and two people with the rank of Bhayangkara Police Two (Bharada).

The 24 personnel include a work unit, ten personnel from the Propane Division, two Bareskrim personnel, two personnel from Korbrimob BKO Propane, nine personnel from the Metro Police or South Jakarta Police, and one Central Java Police personnel BKO Program. Examined 83 Police personnel related to unprofessional procedural violations in handling the Duren Tiga crime scene. Of these, 35 people were recommended for special placements (patsus). 18 people, then the number was reduced by three people, namely Ferdy Sambo, Richard Eliezer, and Ricky Rizal because the three were named suspects in the premeditated murder of Brigadier J. The remaining 15 people, based on the results of an in-depth examination, there are six people who should be suspected of having committed the crime of obstruction of justice, namely obstructing the investigation. "Ferdy Sambo, Brigadier General Hendra Kurniawan, Kombes Pol. Agus Nurpatria, AKBP Arif Rahman Arifin, Commissioner Baiqui Wibowo, Commissioner Cuk Putranto, Kombes Pol. Budhi Herdi Susianto, Deputy Director General of the Polda Metro Jaya Kombes Pol. Jerry Raymond Siagian, as well as two suspects in the premeditated murder of Brigadier J, namely Bripka Ricky Rizal Wibowo and Bharada Richard Eliezer Pudihang Lumia".
