

## ABSTRAK

**Ratna. 105251104120. 2024.** Tinjauan Hukum Islam Terhadap Praktik Pembulatan Nominal Harga Dalam Transaksi Jual Beli (Studi Kasus Minimarket Kecamatan Rappocini). Dibimbing oleh Muchlis Mappangaja dan Jasri.

Penelitian ini dilakukan berdasarkan maraknya praktik pembulatan nominal harga di minimarket yang terkadang menimbulkan kerugian bagi salah satu pihak. Tujuan penelitian untuk mengetahui apakah hukum Islam yang menjunjung tinggi keadilan berpengaruh terhadap praktik pembulatan nominal harga di minimarket.

Penelitian ini dilakukan dengan menggunakan metode kuantitatif dengan total sampel berjumlah 52. Pengumpulan data dilakukan dengan cara menyebar kuesioner kepada masyarakat yang mengetahui atau pernah melakukan praktik pembulatan nominal harga di minimarket. Selanjutnya data yang diperoleh tersebut kemudian diolah melalui metode Partial Least Square (PLS).

Hasil penelitian ini menunjukkan bahwa seluruh hipotesis diterima karena nilai t value > nilai t tabel 1.96 dan nilai p value > 0.05. Variabel hukum Islam berpengaruh signifikan terhadap variabel jual beli dengan nilai t-value 11.898 dan p-value 0.0, variabel hukum Islam berpengaruh signifikan terhadap variabel pembulatan nominal harga dengan nilai t-value 2.823 dan p-value 0.005, variabel hukum Islam berpengaruh terhadap variabel minimarket dengan nilai t-value 2.102 dan p-value 0.036, variabel jual beli berpengaruh signifikan terhadap variabel pembulatan nominal harga dengan nilai t-value 2.404 dan p-value 0.016, variabel jual beli berpengaruh terhadap variabel minimarket dengan nilai t-value 2.121 dan p-value 0.034, dan variabel pembulatan nominal harga berpengaruh signifikan terhadap variabel minimarket dengan nilai t-value 2.321 dan p-value 0,02.

Hukum Islam berpengaruh terhadap praktik pembulatan nominal harga yang dilakukan masyarakat di minimarket. Seperti diterapkannya prinsip antaradhin dan khiyar sebelum melakukan praktik tersebut. Meskipun hal itu hanya berlaku di beberapa minimarket saja. Karena masih terdapat minimarket yang belum menerapkannya secara optimal.

## ABSTRACT

This research was conducted based on the widespread practice of rounding the nominal price in minimarkets which sometimes causes harm to one party. The purpose of the study was to determine whether Islamic law that upholds justice affects the practice of rounding nominal prices in minimarkets.

This research was conducted using quantitative methods with a total sample size of 52. Data collection is done by distributing questionnaires to people who know or have done the practice of nominal price rounding in minimarkets. Furthermore, the data obtained is then processed through the Partial Least Square (PLS) method.

The results of this study indicate that all hypotheses are accepted because the  $t$  value  $>$   $t$  table value 1.96 and  $p$  value  $>$  0.05. The Islamic law variable has a significant effect on the buying and selling variable with a  $t$ -value of 11.898 and a  $p$ -value of 0.0, the Islamic law variable has a significant effect on the nominal price rounding variable with a  $t$ -value of 2.823 and a  $p$ -value of 0.005, the Islamic law variable has an effect on the minimarket variable with a  $t$ -value of 2.102 and a  $p$ -value of 0.036. 036, the buying and selling variable has a significant effect on the nominal price rounding variable with a  $t$ -value of 2.404 and a  $p$ -value of 0.016, the buying and selling variable affects the minimarket variable with a  $t$ -value of 2.121 and a  $p$ -value of 0.034, and the nominal price rounding variable has a significant effect on the minimarket variable with a  $t$ -value of 2.321 and a  $p$ -value of 0.02.

Islamic law affects the practice of nominal price rounding by the community in minimarkets. Such as the application of the principles of an-taradhin and khiyar before carrying out the practice. Although it only applies in some minimarkets. Because there are still minimarkets that have not implemented it optimally.
