

## ABSTRAK

**Sawaluddin Latif. 105 261 105 020.** *Perceraian Karena Nikah Dini di Kecamatan Bulupoddo Tahun 2020-2021* (Studi Kasus di PA Kabupaten Sinjai) Program Studi Ahwal Syakhshiyah (Hukum Keluarga), Fakutas Agama Islam, Universitas Muhammadiyah Makassar.

Dalam penulisan skripsi ini penulis mengangkat beberapa pokok permasalahan yakni apa saja faktor yang mempengaruhi terjadinya kasus pernikahan dini di Kecamatan Bulupoddo Tahun 2020-2021 dan bagaimana pengaruh pernikahan dini terhadap perceraian di kecamatan Bulupoddo. Dalam penulisan skripsi ini, penulis dibimbing oleh Abbas Baco Miro dan Zainal Abidin. Penelitian ini disusun dengan menggunakan metode deskriptif kualitatif dengan tipe peneleitian lapangan (Field research). Penelitian ini berlokasi di Kecamatan Bulupoddo, Kabupaten Sinjai, dan Peradilan Agama Kabupaten Sinjai. Adapun teknik yang digunakan dalam penelitian ini adalah observasi, wawancara, dokumentasi, dan analisis data yang dimaksudkan untuk mengetahui realitas yang terjadi di lapangan

Berdasarkan hasil penelitian yang telah penulis lakukan di lapangan, maka penulis berkesimpulan bahwa faktor yang mempengaruhi terjadinya pernikahan dini di Kecamatan Bulupoddo tahun 2020-2021 ialah karena hamil di luar nikah, dan faktor keluarga, dan pernikahan dini tidak mempengaruhi tingkat perceraian yang terjadi di Kecamatan Bulupoddo karena upaya massif dari KUA Bulupoddo dalam mencegah pernikahan dini dan perceraian seperti: pelayanandi bidang administrasi, penyuluhan sosialisasi undang-undang perkawinan, pelayanan di bidang administrasi dan keluarga sakinah. Dalam pencegahan upaya pencegahan pernikahan dini KUA juga melibatkan Pemerintah Kecamatan Bulupoddo, serta kepolisian dari POLSEK Bulupoddo dan juga pengarahan kepada seluruh pemerintah desa untuk tidak melayani dan menghadiri penggelaran pesta pernikahan dari mempelai yang melaksanakan pernikahan dini.

## ABSTRACT

In writing this thesis, the author raises several issues, namely what are the factors that influence the occurrence of early marriage cases in Bulupoddo District in 2020-2021 and how the influence of early marriage on divorce in Bulupoddo District. In writing this thesis, the author was guided by Abbas Baco Miro and Zainal Abidin. This research was prepared using qualitative descriptive methods with the type of field research (Field research). This research was located in Bulupoddo District, Sinjai Regency, and Sinjai District Religious Court. The techniques used in this study are observation, interviews, documentation, and data analysis intended to find out the reality that occurs in the field

Based on the results of research that the author has conducted in the field, the author concludes that the factors that influence the occurrence of early marriage in Bulupoddo District in 2020-2021 are due to pregnancy out of wedlock, and family factors, and early marriage does not affect the divorce rate that occurs in Bulupoddo District due to the massive efforts of KUA Bulupoddo in preventing early marriage and divorce such as: Services in the field of administration, counseling socialization of marriage law, services in the field of administration and family sakinah. In preventing early marriage prevention efforts, KUA also involves the Bulupoddo District Government, as well as police from the Bulupoddo Police Station and also directs all village governments not to serve and attend the wedding party of the bride and groom who carry out early marriage.
