

## ABSTRAK

**MU'ARIF.** 2024. Implementasi Prinsip-Prinsip Good Governance pada Otonomi Daerah di Kantor Kecamatan Tinambung, Kabupaten Polewali Mandar. Skripsi, Jurusan Pendidikan Pancasila dan Kewarganegaraan, Fakultas Keguruan dan Ilmu Pendidikan, Universitas Muhammadiyah Makassar. Dibimbing oleh Andi Sugiati dan Auliah Andika Rukman.

Penelitian ini bertujuan untuk mengevaluasi implementasi prinsip-prinsip good governance di Kantor Kecamatan Tinambung, Kabupaten Polewali Mandar, dengan fokus pada identifikasi penerapan prinsip-prinsip tersebut serta faktor-faktor penghambatnya. Metode penelitian yang digunakan adalah kualitatif, melibatkan dua informan dari kantor kecamatan dan 30 responden masyarakat melalui kuesioner. Empat indikator yang dianalisis meliputi akuntabilitas, transparansi, partisipasi masyarakat, dan penegakan hukum.

Hasil penelitian menunjukkan bahwa Kantor Kecamatan Tinambung telah menunjukkan kinerja yang baik dalam hal kejujuran, kepatuhan terhadap prosedur, penyediaan informasi, kemudahan akses, proses pengaduan, serta partisipasi dan keterlibatan masyarakat. Namun, masih terdapat tantangan dalam hal efisiensi pengelolaan, penggunaan teknologi, dan ketidakstabilan prosedur. Untuk meningkatkan pelayanan publik, diperlukan evaluasi dan perbaikan dalam integrasi teknologi, aksesibilitas informasi, dan mekanisme pengelolaan. Peningkatan pemahaman terhadap konteks kultural dan sosial, manajemen sumber daya, serta kepemimpinan yang responsif diharapkan dapat memperbaiki efektivitas administrasi dan mendukung perubahan sosial yang lebih efektif.

## ABSTRAK

This research aims to evaluate the implementation of good governance principles in the Tinambung District Office, Polewali Mandar Regency, with a focus on identifying the application of these principles and the inhibiting factors. The research method used was qualitative, involving two informants from the sub-district office and 30 community respondents through questionnaires. The four indicators analyzed include accountability, transparency, community participation and law enforcement.

The research results show that the Tinambung District Office has demonstrated good performance in terms of honesty, compliance with procedures, provision of information, ease of access, complaints process, as well as community participation and involvement. However, there are still challenges in terms of management efficiency, use of technology, and procedural instability. To improve public services, evaluation and improvements are needed in technology integration, information accessibility and management mechanisms. Increasing understanding of cultural and social contexts, resource management, and responsive leadership are expected to improve administrative effectiveness and support more effective social change.
